be licensed to do Plumbing in connection with the Department of Public Utilities, from date hereof to and including the 31 day of December, 20____, The Department of Public Service of said City of Toledo, and any and all persons for whom said plumber shall perform work under said license, shall be indemnified and saved harmless of and from all accidents and damages consequent thereon, for or by reason of any opening in any street, alley or avenue, made by the said _____ or by those in _____ employment, for the purpose of putting down any service pipe or pipes or the installing of any plumbing in any public or private buildings for the introduction of water, or for making any connection with any public or private service or water pipe, or for any other purpose of object whatever, and from any failure on the part of the said _____ to replace and restore the street pavement over such opening to as good state and condition as he found it, and to keep and maintain the same in good order, to the satisfaction of the Department of Public Utilities and the Division of Inspection of said City, for the period of twelve months next thereafter, and from any failure to conform in all respects to the rules and regulations established by the said Department. If all and every damage resulting from accident, as above stated be assumed and settled promptly by the said _____ without loss or damage to the City of Toledo and Department of Public Service, or to any and all persons for whom said plumber shall perform work under said license, and all fines imposed by said Department for violation of any of the Rules and Regulations for the management and protection of the Department of Public Utilities be paid, then this obligation to be void and of no effect, otherwise to be in full force and virtue.
